## **MARKET INFORMATION:**

The Art and Music Festival will be held on Churchill Island on Sunday January 10th 2010. Stallholders are expected to arrive for set up no later than 8.30 AM. (ANY PROBLEMS **PLEASE CALL SIAN ON 59566377/ 0418519181**) Food vendors will require their own insurance only. Art stall holders are covered under our market policy. Should any stallholders require power, please ensure that you have up to date tagged power leads as there will be an OHS representative on hand for site checks. Stalls and sites are allocated at the management's discretion. Tents, umbrellas and trestles are the sole responsibility of the stallholder.

**STALL HOLDER CRITERIA:** All products for sale must be of the highest quality and that the products are hand made and preferably crafted by the stallholder. Please note that market management will not accept mass produced goods. For applications to be processed, photos of artwork or products will need to be forwarded before a site can be allocated, unless you have already been selected to exhibit in previous festivals. The market management reserves the right to refuse an application should the goods be deemed unsuitable for the festival.

**RULES AND REGULATIONS:** Stallholders are responsible for leaving their sites clean and free of rubbish. Tents and covers should be secure at all times and if stalls are using any fire or gas for food or demonstration, they will need an extinguisher or fire blanket on site. It is the responsibility of the stallholder to trade in accordance with the Market, State and Local shire regulations and ensure that they conform to any Australian standards pertaining to their product. **Cars may not move about the market area 15 minutes prior to or after the advertised closing time, due to safety reasons. Stalls may not pack up before advertised closing time.** Festival organizers are not responsible for any adverse weather and no refunds will be given for this reason. Notification of non-attendance is required. A refund, less \$30.00 for admin costs will be paid providing the booking, not the site, was reallocated. A request for a refund must be in writing within 14 days. The market management accepts no responsibility for damages to persons or goods.
